## **Compliance**

This document is to be taken as the Company's written procedure for Handling Client Money.

These written procedures are set out to ensure compliance with:

- The Property Ombudsman Code of Practice;
- Propertymark Conduct and Membership Rules;
- UKALA Conduct and Membership Rules;
- The Client Money Protection Schemes for Property Agents (Approval and Designation of Schemes) Regulations 2018; and

Any other regulations and statutory requirements as necessary, and to maintain the best practice.

Definition of Client Money	<ul> <li>Client money relates to money of any currency, whether in the form of cash, cheque, or electronic transfer, which is:</li> <li>Held or received on behalf of another person, including money held by a regulated firm as stakeholder.</li> <li>Is not immediately due and payable on demand.</li> </ul>
How and where Client Money is held	<ul> <li>We ensure that:</li> <li>We hold clients' money in one or more client bank accounts separate from all other monies;</li> <li>Client money is available on demand;</li> <li>The bank account is correctly titled to include the name of the Company and the word "client" to distinguish the account from an office or any other account; and</li> <li>We have obtained written consent if the Company is to retain interest.</li> </ul>
Handling of Client Money Written Procedures	<ul> <li>We adhere to the relevant Schemes Rules of Conduct and any other regulations as necessary by adhering to the following procedures:</li> <li>All Client Money is held in a Client Money Account with an authorised bank or building society, details of this can be found in our terms of business;</li> <li>We maintain one or more Client Money Account(s) into which all Client Money is paid;</li> <li>We ensure that Client Money Account(s) are designated as such and are easily distinguished from other accounts;</li> <li>We have confirmed in writing with the bank holding the Client Money Account that the bank acknowledges that monies in the Client Money Account must not be combined with, or transferred to, any other account maintained by the Company, and the bank shall not be entitled to exercise any right of set off or counterclaim against the money in that Client Money Account in respect of any sum owed to it in respect of any other accounts that show all dealings with Client Money and demonstrate that all Client Money held by the Company is held in a Client Money Account;</li> <li>We publish our procedures for handling Client Money to any person who may reasonably require a copy, free of charge;</li> <li>We keep records and accounts that show all dealings with Client Money;</li> <li>We repay any Client Money without delay if there is no longer any requirement to retain that money or the relevant client requests it; and</li> <li>We hold and maintain Professional Indemnity insurance cover that is appropriate for the Company's size, income, type of work and the amount of Client Money held.</li> </ul>

General Controls	<ul> <li>We ensure that:</li> <li>Employees have clear segregation of duties and responsibilities and that a Principal or appropriately qualified individual oversees the client accounting function;</li> <li>It employs competent and knowledgeable staff who are responsible for processing clients' money and who are familiar with Client Accounting rules;</li> <li>Accounting systems and client data are securely controlled and protected;</li> <li>Computer systems are adequately protected for access, firewalls, back-ups and disaster recovery;</li> <li>There is adequate cover for holiday and long-term absence;</li> <li>Principals cannot and do not override controls surrounding the accounting system; and</li> <li>All areas of the business apply the same level of controls in relation to the client accounting function.</li> </ul>
Client accounting systems and reconciliation of accounts	<ul> <li>We ensure that:</li> <li>Systems provide details of all money received into and paid from all client accounts and show a running balance of all client money held in that account;</li> <li>Systems identify all receipts and payments to the client to which they relate; for example, by means of client ledgers showing cash balances held on behalf of clients at all times;</li> <li>All ledgers have the client name and an appropriate description, e.g. the property address;</li> <li>Overdrawn balances on client ledgers are prevented by the systems or controls in place and where they do occur are investigated and rectified immediately;</li> <li>Adequate controls are in place over unidentified client money to ensure that such funds are kept securely. The client should be located and reimbursed as soon as possible. Such funds held for more than six years may be donated to a registered charity;</li> <li>A central list of client bank accounts is maintained including dates of opening and closing of accounts;</li> <li>A reconciliation is completed at least once every month where clients' money is held in a general client account. This is produced as a formal statement, and any unresolved differences or adjustments are fully investigated and explained. Any errors identified in the reconciliation process are promptly rectified;</li> <li>Reconciliations are reviewed and signed off by a Principal or an appropriate independent senior member of staff; and</li> <li>Client accounting records, including copies of reconciliations, are securely kept for at least six years plus the current year.</li> </ul>
Controls over the payment of Client Money	<ul> <li>We ensure that:</li> <li>Checks are made to ensure that sufficient funds are held on behalf of the relevant client before payments are made;</li> <li>A copy of the bank mandate is held and is up to date;</li> <li>Adequate authorisation and supervision procedures are in place for payments made by cheque, bank transfer and electronic methods;</li> <li>All payment requests have supporting evidence and that documentation has been authorised in advance by a Principal or other appropriate person;</li> <li>Blank cheques are not signed, and unused cheques are kept securely;</li> <li>Effective controls are in place over the setting up of new supplier accounts on the system; and</li> <li>Cash payments are not accepted.</li> </ul>
